Chi Wei Su is a distinguished professor and doctoral supervisor at Qingdao University. He is also the dean of the Capital Market Research Institute and the deputy director of the China Center for Financial Inclusion Research. He has been recognized as one of the world's top 2% scientists by Stanford University and was listed in the World's Most Influential Researchers list (1% of the World, Clarivate).

Alexandra Horobet is Full Professor at the Department of International Business and Economics within the Bucharest University of Economic Studies, Romania, and holds a PhD in International Business and Economics. Since 2016, she is member of the Economic Sciences commission within the National Council for Attestation of University Titles, Diplomas and Certificates in Romania.

- After the conference, the authors should submit the paper presented at the IECS via Easy Chair system, no later than **July 1, 2024**. Papers written in English should be of 6-14 pages long and must comply with the guidelines described in the **IECS 2024 Template**.
- Participants can send up to two papers as a single author or in collaboration.
